

Applicability	Adult Education Teacher employed in an assignment for a minimum of 32.5 hours per week (exclusive of a one-half hour meal period) having a fixed duration of at least thirteen (13) weeks exclusive of vacations.								
Appointment	Short Term Adult Education Teachers will receive term appointments consistent with the length of their assignment. Such appointments will not accrue tenure or permanent status rights and may be discontinued for any reason.								
Compensation	Short Term Adult Education Teachers will be paid on an hourly basis with rate increases subject to negotiations with OCMBFT.								
Holiday Pay	Payment for holidays occurring within the term of appointment. No payment for floating holiday(s) that may be included in the holiday schedule.								
Bereavement Leave	Payment for up to two bereavement days per year for death in the immediate family. Immediate family is defined in Section G of Article XI.								
Cancer Screening	Up to 4 hours per year cancer screening exam.								
PTO / Earned Leave Credit	8 days of Paid Time Off (<i>PTO</i>) credited at the beginning of each fiscal year (July 1). Initial credit for new employees is prorated from the date of employment through June 30 and credited upon employment. Any PTO not used by fiscal year end (June 30) will be converted to Earned Leave Credit (<i>ELC</i>) hours and paid to employee on July 30. ELC hours are earned at the rate of one (1) hours pay for each thirty-two (32) hours worked (not to exceed 60 hours total).								
Emergency Closing	Payment for emergency or weather-related closings causing cancellation of classes.								
Health Insurance	Excellus Blue Cross/Blue Shield, Major Medical and prescription drug coverage. BOCES contributes 90% of the monthly premium cost for individual coverage or family coverage. Coverage will commence on the first of the month coinciding with or following the effective date of employment and continue through the end of the month of the teacher's term of employment. Teachers will not be entitled to accrue continued insurance benefits upon retirement.
